In 1971, Egil "Bud" Krogh was a 31-year-old White House deputy counsel. He became co-director of the Special Investigations Unit, familiarly known as the "White House Plumbers." He authorized the burglary of Dr. Lewis Fielding's office in an attempt to discredit Daniel Ellsberg, who released the Pentagon Papers without authorization. Krogh alone pled guilty, was disbarred and went to prison. In 1980, Krogh successfully petitioned to be readmitted to the bar and has been in practice since.
